III. Green Team Actions and Community Service Activities for Clean Water

In the Chesapeake Bay Watershed area, streams and rivers provide the water we drink, the food that's grown on our farmlands, protect our health, and provide well-being and peace from nature. The streams and river network flows across more than 380 miles and connects local communities and states to forests, farms, cities and the Atlantic Ocean through the Chesapeake Bay. In light of the local, regional and greater national and world community service goals of the Universal House of Justice 9 Year Plan, the Green Team invites adults (of all ages), youth and families to volunteer for upcoming Chesapeake stream/river/watershed clean ups.

The Green Team cooperates with local community groups, civic environmental/climate change/conservation organizations, public-private Chesapeake Bay conservation groups, and Interfaith partners for the Chesapeake

Region to help protect clean drinking water. Since the Fall season in 2022, Green Team members and friends in Montgomery County, Maryland, Fairfax County, Virginia, and the Baltimore, City/County areas participated in local community stream and park clean up activities.

1. Chesapeake Stream/River and Park Clean Up Community Service Activities

In local communities, cities and heavily urbanized counties surrounding Montgomery County, Fairfax County and

Washington, DC, polluted stormwater runoff is the greatest threat to drinking water quality in our area. The polluted stormwater runoff is the only growing source of pollution to the Potomac River and Chesapeake Bay. Trash and plastic are major sources of stormwater pollution in local streams and rivers that flow into the Chesapeake Bay watershed. Pollution from trash and plastic is now a major threat to water quality and public health in Montgomery County, Fairfax County, Baltimore City/County and the Chesapeake Bay Watershed region. Our participation in volunteer community service and conservation activities sponsored by civic groups, environmental organizations, local/county/state governments and nature conservancies protects local streams, rivers and parklands - and makes them cleaner, safer, and more beautiful for all.

IV. Green Team Community Service for Chesapeake Native Tree Planting, Invasive Weed Removal and Forest Conservation

1. Native Tree and Forests

restoration events.

Trees and forests naturally filter out toxins, improve water quality and reduce air pollution. The native trees and forests across the Chesapeake region provide the cleanest waters to the Potomac River. For climate

resilience, trees cool our cities, and provide homes and food for wildlife. The tree leaves produce life-giving oxygen required for human and animal life, and their roots reduce soil erosion and absorb pollutants that would otherwise pollute our Chesapeake Bay rivers and streams. Finally, tree branches and trunks are a fundamental component of natural habitats and homes for birds and animal wildlife including the Great Blue Heron and American bald eagle.

2. Invasive Plant and Weed Management

The Green Team works with local community and civic organizations, local county and state governments to reduce invasive plants that destroy native trees and forests across the Chesapeake region. Non-native, invasive plants pose a serious threat to the clean drinking water and human/plant/animal and environmental health of the Chesapeake Bay watershed. Oriental bittersweet is one of dozens of non-native weeds, trees, shrubs and grasses that are aggressively invading the Chesapeake Bay watershed's delicate ecosystems. Non-native weeds are not originally from this region, and do not have any predators, parasites or pathogens here to limit their spread. Invasive weeds now threaten, Chesapeake native ecosystems, wildlife, sustainable environment and clean water for the following reasons:

- Out-compete beneficial native plants and trees across the Chesapeake region
- Replace native food and habitat that birds and other wildlife depend upon
- Eliminate host plants for native insects such as butterflies
- Disrupt plant-pollinator relationships, which allow native plants to reproduce
- Aggressive and rapid growth accelerate water pollution and climate related damage to Chesapeake communities, natural resources and economies.

Plants and trees that were historically imported from other parts of the nation - and the world - bring unintended harm to the Chesapeake Bay watershed and natural ecosystem. As a result, clean water, local native trees, forests, plants, animals and marine life are now at risk from non-native invasive species.

3. Native Tree and Forest Protection/Invasive Plant Species Removal

In the Chesapeake Bay region, native trees and plants are now required for clean water, sustainable environment and climate resilience. The native trees and forests are adapted to local soil, rainfall, and temperature conditions, and have developed natural defenses to withstand many types of insects, diseases - and thrive with minimal maintenance. For these reasons, native tree and forest restoration goals set by the U.S. Environmental Protection Agency's Chesapeake Bay cleanup plan call for 900 miles of streamside forests - also called riparian buffers - to be planted each year until 70 percent of all streams in the Bay region are lined with trees.

V. Green Living for Care of God's Creation: Sustainable Environment, Renewable Lifestyles, Climate Resilience in the Chesapeake Bay Watershed Community – and the World

The Green Team is developing information and resources for Green Living as a foundation for Care of God's Creation. The compilation of information and resources for individual, household and community transitions to Green Living combines spiritual, public policy and scientific information and recommendations. Green Living means practicing our faith through Care for God's Creation. Each of us has the power to make lifestyle choices – and take decisions as a Faith Community - that reflects our spiritual responsibilities to protect nature and the natural environment. The Green Living guide is designed to support individual lifestyle and community action changes - and offers resources and ideas to assist in greening our lives and sharing God's love with the world.

The Green Team and its Clean Water and Native Tree/Forest Restoration Working Groups will review the latest U.S. Environmental Protection Agency (EPA) and U.S. Department of Energy recommendations and standards for energy efficient and water efficient household appliances and consumer products for Green Living. For renewable clean energy transition to reduce carbon emissions, the Green Team is researching public information and resources available for the transition to electric vehicles and transportation and – the phase out of gas fueled appliances and HVAC systems in homes and buildings. The information will be combined with current Care of Creation protocols for individuals and Faith Communities and presented to our LSAs, communities and clusters. The ultimate goal of the Green Living information and resource document is to increase and strengthen our participation in public education, community service and engagement for the common good of our local Chesapeake community, states, the nation and the world.

The meeting concluded with a Call for Youth Community Service and Conservation Volunteers, and participation in upcoming Green Team activities for native tree planting, invasive weed removal and Chesapeake Bay stream/river clean up.

VI. Green Team Policy and Care for Creation Advocacy News: Sustainable/ Renewable Environment and Climate Resilience

Across the Chesapeake Bay watershed region, local communities, county and state governments, interfaith groups and civic organizations are working to restore and protect clean water, native trees and forests, and wildlife ecosystems. In Montgomery County and Baltimore, Maryland, Fairfax County and Northern Virginia, the District of Columbia and the Chesapeake Bay area, utility companies, municipalities, cities, counties and states are working in cooperation to implement standards for sustainable environment, clean renewable energy transition and climate change resilience. To achieve these goals for the common good of Chesapeake Bay communities and states, science based water quality, stream and river pollution removal, native tree planting, forest conservation and land preservation require volunteer service for conservation. In the State of Maryland, the 5 million native tree planting program for climate resilience is now underway. In Fairfax County, Virginia, an urban tree and forestry plan is now implemented. In the Baltimore area, urban and county wide native tree planting programs are underway to protect clean drinking water in the Chesapeake Bay watershed.
